An Act to amend the Cooperative Societies Act, 1982, to provide for and to take cognisance of statutory provisions on the formation of a National Apex Organization for the whole of the United Republic

ENACTED by the Parliament of the United Republic of Tanzania.

1. This Act may be cited as the Cooperative Societies (Amendment) Act, 1990, and shall be read as one with the Cooperative Societies Act, 1982, in this Act referred to as "the principal Act"

2. This Act shall come into operation on such date as the National Apex Organization Act, 1990, comes into operation.

3. Section 2 of the principal Act is hereby amended-

- (a) by inserting after the definition "Minister" the following definition— "national apex organisation" means the national apex oganization formed under the National Apex Organization Act, 1990,"
- (b) in the definition "Secretary General" by inserting immediately before the word "apex" the word "national";
- (c) in the definition "society" by deleting the words "an apex organization" and substituting for them the words "the national apex organization;"
