| Amendment of
regulation 3 | 2. The principal Regulations are amended in regulation 3 by deleting it and substituting for it with the following:
“3. There shall be established a fund to be known as TCAA Training Fund.” |

regulation 5 | 3. The principal Regulations are amended in regulation 5 by deleting the words “or grant” |
| Amendment of
regulation 11 | 4. The principal Regulations are amended in regulation 11 by inserting new paragraphs after paragraph (b) of sub-regulation (2) as follows:
“(c) pass a written and oral aptitude test conducted by qualified technical personnel of the Authority; |

- (d) pass a written and oral aptitude test conducted by qualified technical personnel of the Authority;
- (e) pass a medical examination as required for the course to be taken, and for the pilots, to undergo simulator training and engineer submitted to maintenance organization; and
- (f) make a written application in a prescribed form in which shall be included-
 - (i) the name of the applicant; and
 - (ii) the applicant's parent or guardian, and applicant's guarantor

5. The principal Regulations are amended in regulation 12 by deleting sub-regulation (2) and substituting for it with the following:

“(2) The selection committee shall be responsible to prepare a shortlist of eligible candidates recommended for a loan and submit it to committee for approval.”

Amendment of
regulation 13

6. The principal Regulations are amended in regulation 13(2) by deleting it and substituting for it with the following:

“(2) The beneficiary of training sponsorship and his parent or guardian shall enter into an agreement with the committee to repay the loan upon completion, suspension or termination of training under any circumstances resulting from the acts or omission of the student.”
