- 4. Tendering will be conducted through the **National Competitive Tendering (NCT)** procedures specified in the Public Procurement (Regulations, 2013 Government Notice No. 446 as amended in 2016 and is open to all Tenderers as defined in the Regulations.

A complete set of Tendering Documents in **English Language** and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **TZS. 100,000.00**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **Clerk of the National Assembly**.

- 7. All Tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.
- 8. All Tenders in one original plus **Two Copies**, properly filled in, and enclosed in plain envelopes must be delivered to the address **Secretary of the Tender Board**, **Office of the National Assembly Dodoma**. **Administration Block**, **Second Floor**, **Room No. 222** at or before **14:30 hours local time on 22**nd **October**, **2019**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **Office of the National Assembly Dodoma**. **Administration Block**, **Second Floor**, **Conference Room No. 227**.
- 9. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, and not opened and not read out in public at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
