An Act to apply a further sum of one hundred and twenty-two thousand four hundred and fifteen pounds out of the Consolidated Fund to the service of the year ending on the thirtieth day of June, one thousand nine hundred and sixty-three, and to appropriate the supply granted

[17TH MAY, 1963]

ENACTED by the Parliament of Tanganyika.

1.—(1) This Act may be cited as the Supplementary Appropriation Short title and construction
(1962–1963) (No. 2) Act, 1963.

(2) The expressions used in this Act shall have the meanings respectively ascribed thereto in the Exchequer and Audit Ordinance, Ord. 1961 No. 21
1961.

2. The Treasury may issue out of the Consolidated Fund and apply Issue of £122,415 out of Consolidated Fund
towards the supply granted for the service of the year ending on the thirtieth day of June, 1963 the sum of one hundred and twenty-two thousand four hundred and fifteen pounds.

3. The sum granted by section 2 shall be appropriated to the purposes Appropriation of moneys voted
and in the amount specified in the second and third columns of the Schedule to this Act.

4. In addition to the sums granted out of the Consolidated Fund Appropriations-in-aid
under section 2, there may be applied out of any moneys directed, under section 9 of the Exchequer and Audit Ordinance, 1961, to be applied as appropriations-in-aid, the amounts respectively set forth in the fourth column of the Schedule to this Act.

5.—(1) The Minister may at any time or times not later than the Power of the Minister to borrow
thirtieth day of June, 1963, borrow within or outside Tanganyika, or partly within and partly outside Tanganyika any sum or sums not exceeding in the whole one hundred and twenty-two thousand four hundred and fifteen pounds, by way of loan, advance, the issue of bills or bank overdraft and on such terms and conditions as the Minister may deem expedient, and may charge any such loan or advance on any of the assets of the Territory (including securities forming part of the Consolidated Fund).

(2) Any money borrowed under this section shall be placed to the credit of the exchequer account and shall form part of the Consolidated Fund, and be available in any manner in which such Fund is available.

(3) Any money borrowed under this section shall be subject to repayment not later than the thirty-first day of October, 1963; and any sum required for the repayment of any money so borrowed, and of any interest payable thereon shall be charged on and paid out of the Consolidated Fund.
